## **COVID PROTOCOLS** **Indoor Pickleball**

**Updated February 17, 2021**

### **HEALTH SCREENING & SIGN-IN PROCEDURE:**

1. Please stay home if
  - a. You are sick or ill.
  - b. You are experiencing symptoms of COVID.
  - c. You have tested positive or been in contact with someone who has tested positive for COVID.
  - d. You are awaiting results from COVID test.
  - e. You are under quarantine
2. All participants must consent to a health screening upon entry which involves;
  - a. questioning to determine whether you have been exposed to or are at risk for having COVID
  - b. having your temperature taken with a non-invasive forehead scanner upon entry.
    - i. (If temperature reading is 100.4 or greater, you must go home.)
    - ii. **WE WILL ONLY TAKE THE TEMPERATURE ONCE**. If your temperature is 100.4 or higher, we will not wait and take it again to see if it goes down.
3. All participants must wash/sanitize their hands after they have been signed in. (*touch-less hand sanitizer stations will be available at the sign-in post.*)

### **MASKS:**

1. All participants must wear a mask upon entry and exit of the facility.
2. Masks should be worn whenever not playing, waiting to play, using the restrooms, moving throughout the facility, and any other occasion except for while playing.
3. Masks are not required while playing but are strongly encouraged.

### **PHYSICAL DISTANCING:**

1. All participants must practice social distancing as much as possible whenever not playing.

### **EQUIPMENT:**

1. Each participant should use their own paddle. If you do not have a paddle, you may borrow one of ours. Do not share used paddles.
2. Our paddles will be cleaned and disinfected prior to each class.
3. Pickleballs will be cleaned and disinfected prior to each class.

### **WATER BOTTLES:**

1. Please remember to bring a labelled bottle of water.
2. We have a re-fill station located in our lobby that you can use to re-fill your water bottle.
3. We are not permitted to use the water fountain due to COVID.

### **OTHER:**

Please do not hand the ball to another person. Please pass or roll it to them to limit physical contact.

### **UPDATES:**

Please keep in mind that these procedures may change at any time based on updated guidelines or if deemed necessary.
